IMPORTANT INFORMATION

CREDIT LIFE/DISABILITY NOTICE:

In some cases, identification will be requested for those members conducting business with Befit Financial Federal Credit Union prior to the effective date of the customer identification requirements because original documentation was not obtained with the opening of the account, or Befit Financial Federal Credit Union is unable to form a reasonable belief that it knows the true identity of the existing member. In all cases, protection of our members’ identity and confidentiality is Befit Financial Federal Credit Union’s pledge to you.
