The recent collapse of Silicon Valley Bank is now the second-largest failure of a financial institution in U.S. history after the 2008 financial crisis. Additionally, Signature Bank was shut down by regulators on March 12th, which has understandably caused some concern. However, we want to assure our members that credit unions like Befit Financial FCU operate differently from these banks and engage in less risky ventures, so your money is safe in our hands.

At Befit, we take pride in our proactive approach to monitoring our cash position and investments to ensure that we can withstand any financial challenge that may impact our members. We go above and beyond regulatory guidelines to ensure that our credit union is well-capitalized and strong because we care about your financial health and well-being.

- Deposits in federally insured credit unions are safe and secure. We are federally insured, and deposits are protected by the National Credit Union Share Insurance Fund and insured up to at least \$250,000 per individual depositor — the same as any other federally insured financial institution. - The first credit union in America was founded in 1909. Since then, no Credit Union member has ever lost a penny of insured savings at a federally insured credit union.
